1.0	GENERAL
1.1	Tender Notice:
	Open Tender is invited through E-Tendering system by RITES Ltd., a Public Sector Enterprise under the Ministry of Railways, acting for and on behalf of North Western Railway (NWR) Jaipur (Employer) as an Agent/Power of Attorney Holder, for the work of "Railway Electrification of 25 kV OHE works including Traction Substations, General Electrification, Civil Engineering Works including Tower Wagon Shed, Service Buildings, Staff Quarters, Track works and Signaling & Telecommunication works on existing track of single line section of Udaipur City (Excl.)-Himmatnagar (Excl) section of Ajmer Division, North Western Railway, Rajasthan & Gujarat, India".
	(Note: Throughout these bidding documents, the terms 'bid' and 'tender' and their derivatives are synonymous).
1.2	Estimated Cost:
(a)	The work is estimated to cost Rs. 178,19,02,965.16, (Rupees One Hundred Seventy Eight Crores Nineteen Lakh Two Thousand Nine Hundred Sixty-Five and Sixteen paise only) rounded off to Rs.178.19 crores, excluding GST
(b)	Cost of Tender Document: Rs.18,000/- (Rupees Eighteen Thousand only)
(c)	Earnest Money Deposit (EMD): The Bidders/tenderers are not required to deposit the Earnest Money (Bid Security) along with the bid documents. In place of Earnest Money, it is mandatory that the Bidders/ tenderers shall submit Bid Security Declaration (Annexure 9.2) along with the Bid Documents. Refer GCC July-2019 Correction Slip No. 7
1.3	The following documents (in hard copies) should be submitted within a week of opening of bid. i. 1.0 Important Information

Changes/Amendments/Corrigendum if any, related to the tender document will be posted on E-Procurement Portal https://etenders.gov.in/eprocure/app. Bidders in their own interest must check the website before submitting the bids
- III. In case of any discrepancy in dates mentioned in tender documents and date mentioned in e procurement portal then dates mentioned in e-procurement portal https://etenders.gov.in/eprocure/app shall prevail.
- IV. RITES reserve the right to accept or reject the bid without assigning any reason thereof.
- V. Bids should be submitted **online** in the prescribed format given at E-Procurement Portal https://etenders.gov.in/eprocure/app. No other mode of bid submission is acceptable.

2.0 INSTRUCTIONS ON ACCESSING/PURCHASING OF BID DOCUMENTS AND SUBMISSION THEREOF

- **2.1** To participate in the E-Bid submission for RITES, it is mandatory for the bidders to get their firms registered with E-Procurement Portal https://etenders.gov.in/eprocure/app.
- 2.2 The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

2.3 REGISTRATION

a) <u>Bidders are required to enrol on the e-Procurement module of the Central Public Procurement Portal (URL: https://etenders.gov.in/eprocure/app)</u> by clicking on the link "Online Bidder

Enrolment" on the CPP Portal which is free of charge.

- b) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- c) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- d) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India with their profile.
- e) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSC's to others which may lead to misuse.
- f) Bidder can log in to the site through the secured log-in by entering their user ID/Password and the password of the DSC/e-Token.

3.4 SEARCHING FOR TENDER DOCUMENTS

- a) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, Organization Name, Location, Date, Value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as Organization Name, Form of Contract, Location, Date, Other keywords etc. to search for a tender published on the CPP Portal.
- b) Once the bidders have selected the tenders they are interested in, they may download the required documents/tender schedules. These tenders can be moved to the respective 'My Tenders' folder. This would enable the CPP Portal to intimate the bidders through SMS/E-mail in case there is any corrigendum issued to the tender document.
- c) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification/help from the Helpdesk.
