Sub: Amendment no. 04 to Revised speed certificate for operation of Shatabdi Express and other similar trains hauled by single WAP5 class of locomotive comprising maximum 12 numbers of LHB AC (EOG) coaches including two Generator Vans on New Delhi-Agra Cantt.- New Delhi section of Northern Railway & North Central Railway upto a maximum speed of 160 kmph on track maintained to C&M-I, Vol.-I standard.

Vide reference (i) above, Revised speed certificate was issued for operation of Shatabdi Express and other similar trains hauled by single WAP5 class of locomotive comprising maximum 12 numbers of LHB AC (EOG) coaches including two Generator Vans on New Delhi - Agra Cantt.- New Delhi section of Northern Railway & North Central Railway upto a maximum speed of 160 kmph on track maintained to C&M-I, Vol.-I standard. Further, vide NCR letter no. Mech/75/Part XXIII /Gatiman dt 15.02.2018, it has been requested for extension of route of Gatiman Express upto Jhansi and accordigly, it has been decided to extend the route of Gateman Express upto Jhansi. Shatabdi express (New Delhi-Bhopal Exp.) is already running at speed of 130kmph between Agra Cantt to Jhansi. It has been decided to issue speed certificate for Gatiman Express (train no. 12049 & 12050) max speed upto 160kmph in section New Delhi-Agra Cantt.- New Delhi section of Northern Railway & North Central Railway and max. upto 130 kmph speed in section Agra Cantt.- Jhansi section of North Central Railway.

Accordingly, it has been decided to amend subject and para-(2) of speed certificate ref (i) above as under:-
