Ref: 1. Director Passenger Marketing, Railway Board letter No.TC II/2010/21/Covid 19 review of HSP fare New Delhi dated 12.11.2021.

Dy. Director Coaching, Railway Board Letter No.2021/Chg./33/7 dated 12.11.2021.

In reference to above referred letters, activity analysis and plan for renumbering of trains are as below: -

1. Within the current ARP period, for 3110 active trains, there are around 15000 PNRs associated with each train.

Maximum six trains can be renumbered in 5 minutes.

For downtime of 6 hours per day, 432 trains can be renumbered per day i.e., 360/5 * 6= 432.

Total days with 6 hours down time will be 3110/432 days=7.19 days=7 days.

5. CRIS teams will patch/update the trains during the 6-hour activity of patching/update of train, and the patched/updated data will be tested/verified by railway data base official team during 6-hour activity period itself.

6. Charting of trains getting affected during activity period should be prepared in advance by the

Railways.

7. CRIS will share day wise train number updation list with railway board for directing zonal railways to make simultaneous changes in ICMS during the activity period.

8. SMS would be sent by Railway to affected passengers using existing BULK SMS utility (train and date range wise). SMS template have to be provided by Railway for registration on DLT platform.

9. Train name change utility is already with Railways. The trains which have been renumbered and with their active data patched in night activity may be taken by Railways for renaming of train name if required, using already provisioned utility with them.

Pre-requisite:

- Mapping list of new train number against the old train number to be provided by Zonal Railways.
- ICMS integration layer will be disabled for the entire duration of the train renumbering activity. The train delay and cancellation should be handled by commercial and operating officials manually.
- The six hours activity will start on intervening night of 14-15th November. The activity block will be from 23:30 hrs to 05:30 hrs. Similar activity will take place on next six nights.
- Ticketing facilities will not be available during activity period.

May kindly approve the same.
