- 2. Vide Board's letter No.2010/TC (CR)/2013 dt. 12.06.2013, attachment of Executive AC Chair CAR (LHB) in 12985/12986 Jaipur-Delhi Sarai Rohilla AC Double Decker Express has been approved on a trial basis for a period of 3 months.
