Vide letter under reference, Railway Board has approved the repercussion of coaching trains & freight trains during Mega block of 06.10 hrs (Dn) & 05.10 hrs(Up) simultaneously on UP and Dn road between Sihora-Gosalpur for regirderring of 3<sup>rd</sup> & 5<sup>th</sup> span of Hiran Bridge in JBP-KTE section of Jabalpur Division. Now Mega block has been planned on **05.02.2022 (SAT)** and following trains will be cancelled, short-terminated, Diverted and regulated as per details given below:

**Coaching repercussions-**

**a. Cancellation-**

1. 11705/01706 (JBP-REWA-JBP) Express JCO 05.02.2022.

**b. Short termination/Origination-**

1. 06619/06620 (ET-KTE-ET) MEMU JCO 05.02.2022 at JBP (partially cancelled between JBP-KTE-JBP).
  - On arrival of 06626 STA-KTE MEMU on 05.02.2022 at KTE will be work as 06622 KTE-BINA MEMU with Rescheduling by 120 min.
2. 22190/22189 (REWA-JBP-REWA) JCO 05.02.2022 at KTE.
3. 11265/11266 (JBP-ABKP-JBP) JCO 05.02.2022 at KTE South.  
(The rakes of these trains are interlinked and primary examination is done at Rewa)  
Rake link of intercity trains-
  - Incoming rake of 22190 at KTE will work 11265 from KTE South.
  - Incoming rake of 11266 at KTE South will work 22189 from KTE.

**c. Diversion-**

1. 12150 Up (DNR-PUNE) JCO 04.02.2022 via KTE-KMZ-BINA-ET instead of KTE-JBP-ET.
2. 11062 Up (JYG-LTT) JCO 04.02.2022 via KTE-KMZ-BINA-ET instead of KTE-JBP-ET.
3. 13202 Dn (LTT-PNBE) JCO 04.02.2022 via ET-BINA-KMZ-KTE instead of ET-JBP-KTE.
4. 18610 Dn (LTT-RNC)) JCO 04.02.2022 via ET-BINA-KMZ-KTE instead of ET-JBP-KTE.
5. 20929 Dn (UDN-BSBS) JCO 04.02.2022 via ET-BINA-KMZ-KTE instead of ET-JBP-KTE.

- d. Regulation-** Other train will be regulated on Mega block day and on preparatory block days as per flow of traffic and running of trains.



### **Freight repercussions-**

1. Trains received ex Itarsi and to be handed over to NCR may be moved via BINA instead of JBP. Similarly NKJ bound loads ex Itarsi need to be moved via BINA.
2. Trains going from BSP to NAG (such as VNK, PJPB etc) will have to be moved via Itarsi.
3. Train to be moved from BSP to BPL via JBP (such as NSPN, PSSS etc) will have to be moved via BINA. Similarly trains received ex MHDA too will be moved via BINA. Although NKJ-BINA coal corridor is already heavily congested.
4. NTPB ex BSP should be moved via Itarsi in place of NKJ.
5. PLBG and LPBG ex BPL will be accepted at Itarsi point and the released BTPN /BTPG rakes too will be moved via Itarsi only involving loco reversal at Itarsi station.


### **Important Note:**

#### **Railway Board has approved the block with the following observations:**

1. WCR shall ensure that restrictive SR of 20 kmph is normalized strictly as per timeline fixed by mobilizing adequate resources (welding gangs) so that consumed ETA does not breach the permitted limit.
2. Adequate site preparedness to ensure no block bursting.
3. Any major planned block be avoided on the proposed alternate route for diversion of freight.
