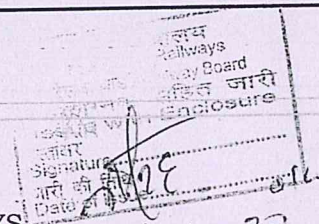

4. ZONAL RAILWAYS SHOULD MAKE EFFORTS TO OPERATE THESE SERVICES WITH MORE NUMBER OF AC-III TIER COACHES IN GOOD CONDITION (.)
