2. Repercussion on freight traffic during PNI/NI works:-

- a. Imposition of speed restriction during BPNI/PNI/NI working 20 kmph speed restriction will be imposed at CTW from D-14 onwards and at NBA from D-18 to D1. During NI period, SR on Main line at NBA & CTW station will be of 30 kmph as per provisions of G&SR and JPO NO. 403-T/JPO/Optg./NI/Speed-30/33/1 dt.01.07.2022.
- b. Gumtee working during PNI/NI: Insertion of points are planned during PNI/NI due to which working of Gumtee will start. 6 Gumties will be provided at NBA w.e.f. D-6 and 4 gummites will be provided at CTW w.e.f. D-5.
- c. Repercussions on NBA Goodshed handling:-
- i) No Military Traffic will be handled at NBA station from D-17 to D-6 as existing Military Traffic handling line No.- 5 will be blocked.
 - ii) From D-5 onwards, Goods traffic and Military traffic will be handed on new Goods line.
 - iii) Placement /removal will be done only from line No.1 for CWHN siding from D-2 to till commissioning.

Restriction on inward traffic in NBA Good shed is required to be imposed from 03.01.23 to 24.01.23 and that on outward traffic from 03.01.23 to 15.01.2023.

d. Non crossing at CTW: From D-5 to D+1 i.e. 7 days, CTW station will remain non crossing as only main Line (Existing L.No.-1) will be available. As a result, NBA-KLSX (20 kms) will work as single block section.

At NBA Line No.3, 4 & 5 will be blocked till commissioning and Line No.1 & 2 will be available till commissioning.

e. Effect on Line Capacity-

At present, 16 coaching trains and about 26 freight trains per day are running on DBN-DUI Section.

Due to PNI/NI blocks, Gumtee working and corresponding slowing down of trains, over all 6 coaching trains and about 15 freight trains will be handled.

Empty jumbo rakes for the section will be supplied before block. Moreover, it is proposed to divert loaded food grains /empty boxn rakes via DUI-JHL and SPR route.

Advise all concerned to please note and act accordingly. Kindly ensure that safety measures/precautions as per rules are taken at work site during the block. Division should also ensure that adjacent divisions are informed well in advance to ensure the effective utilization of block for maintenance work etc.

Advice all concerned to act accordingly. Wide publicity should be given through newspapers, station notice boards, enquiry offices and electronic & print media. Proper announcements regarding cancellation, short termination/origination, diversion, regulation of trains must be ensured for the information of general public.
